WePlanet VWZ was officially incorporated in Belgium as a non-profit organization on 9 February 2022, with the registration number <u>BE0781755464</u>. Our legal form under Belgian law is "non-profit organization" in the environmental sector.

Our ID in the EU Transparency Register is 179551845769–58. Our record can be found <u>here</u>. We completed our 2023 operations and our second financial submission to the register is due on 10 March 2024. An update is to be made in Q3 2024 due to the official name change in June 2024.

WePlanet is both a non-profit organization that covers its own expenses and a subcontractor of charitable funds to member organizations of the WePlanet Alliance, a network of national grassroots groups. As a movement of grassroots activists, the integrity and independence of WePlanet is paramount. We are funded exclusively by charitable donations. We do not accept funding from industry, and all sources of funding above €10,000 are listed by name on our website.

As an organization that boldly takes a stand on controversial issues such as nuclear energy, biotechnology and alternative proteins, we are careful not to accept any funding that could undermine this integrity.

2. Program Transparency

- We provide detailed information about our programs and activities, including goals, methodologies, and outcomes.

- We actively engage with our beneficiaries and communities to gather feedback and ensure that our programs meet their needs.
